STATEMENT OF WORK FOR EVALUATION, TESTING, AND DEVELOPMENT OF A REPAIR PLAN FOR UNIT #7 AT THE RICHARD B. RUSSELL PUMP STORAGE POWER PROJECT

1. General:

The purpose of this acquisition is to assist in performing various aspects of engineering for the Richard B. Russell (RBR) Power Project. There are two phases of work. Phase 1 will be for the contractor to provide technical expertise, testing, and analysis necessary to assist the Corps of Engineers (COE) in determining the root cause of the Unit 7 high temperature problems and the thrust bearing failures described in the section entitled History and to jointly develop a plan for eliminating the sources of the problems that prevents Unit 7 from running reliably. Such activities may involve, but are not limited to:

- a) Site visits to develop a Performance Work Statement for Phase 2 work and Safety Plan for Phase 2.
- b) Inspection of Hydroelectric units
- c) Development of testing procedures and oversight of testing
- d) Evaluation of unit condition
- e) Report of Findings to include the following categories
 - Identification of problems
 - Development of Alternative Solutions
 - Evaluation of Alternatives
 - Recommendation for Resolution of Problems
- f) Assist in development of plans and specifications
- g) Submittal review

Phase 2 will require the contractor to provide technical oversight for using the plan developed in Phase 1 for repairing Unit 7 and returning it to a reliable state for generation and pumping. This may also include site visits to any shops or factories for inspection purposes.

2. History:

The thrust bearings of the reversible pump turbines Units 5-8 at RBR are of a modified Kingsbury design. The rotating components (500+ tons) ride on a typical highly polished and very smooth split thrust runner. The bearing shoes are a typical steel-backing shoe with a babbited wearing surface poured onto the dovetailed surface of the shoes. There are 10 shoes and each weigh 800+ lbs. Each bearing shoe is supported by a hydraulically connected set of swivels whose design is an Alstom proprietary design. Unit 7 thrust bearing failed 26 July 2002. Thorough inspection and replacement of the resurfaced thrust shoes were completed, and the unit was returned to service 27 August 2002. On 3 September 2002, Unit 7 thrust bearings wiped again. Due to in-house repair efforts being unsuccessful, the Original Equipment Manufacturer was contracted for an on-site analysis, engineering, and erecting support. The manufacturer technical expert was unable to identify a reason for the bearing failures. In-house work crew checked and replaced Unit 7 runner and thrust bearings. The unit was reassembled and ran in generation mode for five hours that night. The next morning on 12 February 2003, the thrust bearing failed again after running for only 50 minutes.

3. Objectives:

The overall objective of this contract is for the contractor to provide technical expertise, testing, and analysis necessary to assist the Corps of Engineers (COE) in determining the root cause of the Unit 7 high temperature problems and thrust bearing failures as described above in the section entitled History and to jointly develop a plan for eliminating the sources of the problems that prevents Unit 7 from running reliably. In addition, the contractor is to provide technical oversight for using the plan developed in Phase 1 for repairing Unit 7 and returning it to a reliable state for generation and pumping. The performance period for Phase 1 should not exceed 8 weeks (consisting of 10-hour man-days - 5 days per week).

The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. The Government must exercise its post-acceptance rights (1) within a reasonable time after the defect was discovered or should have been discovered; and (2) before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(b) Assignment. The Contractor or its assignee may assign its rights to receive payment due as a result of performance of this contract to a bank, trust company, or other financing institution, including any Federal lending agency in accordance with the Assignment of Claims Act (31 U.S.C. 3727). (c) Changes. Changes in the terms and conditions of this contract may be made only by written agreement of the parties.

The Contractor shall proceed diligently with performance of this contract, pending final resolution of any dispute arising under the contract.

(k) Taxes. The contract price includes all applicable Federal, State, and local taxes and duties.

(l) Termination for the Government's convenience. The Government reserves the right to terminate this contract, or any part hereof, for its sole convenience. In the event of such termination, the Contractor shall immediately stop all work hereunder and shall immediately cause any and all of its suppliers and subcontractors to cease work. Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage

of the work performed prior to the notice of termination, plus reasonable charges the Contractor can demonstrate to the satisfaction of the Government using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred which reasonably could have been avoided.

(m) Termination for cause. (o) Warranty. The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.

(p) Limitation of liability. Except as otherwise provided by an express warranty, the Contractor will not be liable to the Government for consequential damages resulting from any defect or deficiencies in accepted items.

(q) Other compliances. The Contractor shall comply with all applicable Federal, State and local laws, executive orders, rules and regulations applicable to its performance under this contract.

(c) Before the Contracting Officer makes a final decision that the Contractor has failed to make such good faith effort, the Contracting Officer shall give the Contractor written notice specifying the failure and permitting the Contractor to demonstrate what good faith efforts have been made and to discuss the matter. Failure to respond to the notice may be taken as an admission that no valid explanation exists. If, after consideration of all the pertinent data, the Contracting Officer finds that the Contractor failed to make a good faith effort to comply with the subcontracting plan, the Contracting Officer shall issue a final decision to that effect and require that the Contractor pay the Government liquidated damages as provided in paragraph (b) of this clause.

(d) With respect to commercial plans, the Contracting Officer who approved the plan will perform the functions of the Contracting Officer under this clause on behalf of all agencies with contracts covered by the commercial plan.

(e) The Contractor shall have the right of appeal, under the clause in this contract entitled Disputes, from any final decision of the Contracting Officer.

(f) Liquidated damages shall be in addition to any other remedies that the Government may have.

(d) The Government may at any time reserve additional funds for payments under the contract if there are funds available for such purpose. The contracting officer will promptly notify the contractor of any additional funds reserved for the contract by issuing an administrative modification to the contract.

(e) If earnings will be such that funds reserved for the contract will be exhausted before the end of any fiscal year, the contractor shall give written notice to the contracting officer of the estimated date of exhaustion and the amount of additional funds which will be needed to meet payments due or to become due under the contract during that fiscal year. This notice shall be given not less than 45 nor more than 60 days prior to the estimated date of exhaustion.

(f) No payments will be made after exhaustion of funds except to the extent that additional funds are reserved for the contract. The contractor shall be entitled to simple interest on any payment that the contracting officer determines was actually earned under the terms of the contract and would have been made except for exhaustion of funds. Interest shall be computed from the time such payment would otherwise have been made until actually or constructively made, and shall be at the rate established by the Secretary of the Treasury pursuant to Public Law 92-41, 85 STAT 97, as in effect on the first day of the delay in such payment.

(g) Any suspension, delay, or interruption of work arising from exhaustion or anticipated exhaustion of funds shall not constitute a breach of this contract and shall not entitle the contractor to any price adjustment under the "Suspension of Work" clause or in any other manner under this contract.

(h) An equitable adjustment in performance time shall be made for any increase in the time required for performance of any part of the work arising from exhaustion of funds or the reasonable anticipation of exhaustion of funds.

(i) If, upon the expiration of sixty (60) days after the beginning of the fiscal year following an exhaustion of funds, the Government has failed to reserve sufficient additional funds to cover payments otherwise due, the contractor, by written notice delivered to the contracting officer at any time before such additional funds are reserved, may elect to treat his right to proceed with the work as having been terminated. Such a termination shall be considered a termination for the convenience of the Government.

(j) If at any time it becomes apparent that the funds reserved for any fiscal year are in excess of the funds required to meet all payments due or to become due the contractor because of work performed and to be performed under the contract during the fiscal year, the Government reserves the right, after notice to the contractor, to reduce said reservation by the amount of such excess.

(iii) Ability to control or influence the election, appointment, or tenure of directors or officers in the firm;

(iv) Ownership of 10 percent or more of the assets of a firm such as equipment, buildings, real estate, or other tangible assets of the firm; or

(v) Holding 50 percent or more of the indebtedness of a firm.

(b) "Prohibition on award."
