52.212-3 OFFEROR REPRESENTATIONS AND CERTIFICATIONS--COMMERCIAL ITEMS (JAN 2004)

(a) Definitions. As used in this provision:

"Emerging small business" means a small business concern whose size is no greater than 50 percent of the numerical size standard for the NAICS code designated.

"Forced or indentured child labor" means all work or service-

(1) Exacted from any person under the age of 18 under the menace of any penalty for its nonperformance and for which the worker does not offer himself voluntarily; or

(2) Performed by any person under the age of 18 pursuant to a contract the enforcement of which can be accomplished by process or penalties.

Service-disabled veteran-owned small business concern--

- b. Vehicle registration and proof of insurance
- c. INS Form I-551 or I-151 (Resident Alien Card), if applicable
- d. INS Form I-688A or I-688B (Work Permit), if applicable
- e. Passport with the appropriate INS stamps for work, if applicable

Corps of Engineers Point-Of-Contact (POC), Jon Gibbs, shall be contacted at least 3 days before planned commencement of operations to make necessary on-site coordination. He may be contacted at the Thurmond Lake Resource Manager's office, phone number (864) 333-1118.

C.1.2.2 In addition to the above, the POC for The Corps of Engineers will provide a memorandum to Fort Gordon showing the names of the company and individuals who will be authorized to perform work under this contract. The contractor should keep a copy of this letter in his possession at all times while entering and working on the installation.

C.1.2.3 Access into the Fort Gordon Military Installation for all contractors is via Gate 3 on US Highway 78 from 6:00 am to 5:30 pm weekdays and via Gate 1 on US Highway 78 on weekends and 5:30 pm to 6:00 am weekdays. Fort Gordon Forest Management must approve all weekend work in advance.

C.1.3 Scheduling of Services: Fort Gordon Forest Management personnel will schedule the Contractor's tree planting operations with Range Control in order to prevent interference with military training. POC for Fort Gordon Forest Management is Alan Braswell and he may be contacted at the following phone numbers: (706) 791-9932 or (706) 667-2135 (beeper).

C.1.4 Work Area: All tree planting work described below shall be accomplished within areas located on the Fort Gordon Military Installation. Fort Gordon Forest Management personnel will determine exact areas at time of planting. Areas are open or have recently been harvested and will either have been raked or drum chopped prior to planting. Areas may also be burned prior to planting. Planting areas range in size from 2.5 acres to 86.7 acres. The installation shall be cleared of any cans, containers or other debris discarded by the planting personnel on a daily basis.

C.1.5 Quality Assurance: The Government will provide quality assurance by monitoring the quality control system, inspecting contract performance and reporting deficiencies to the Superintendent for correction.

C.1.5.1 Quality Control: The Contractor shall maintain an inspection system, which shall identify deficiencies in the quality of services performed before the level of performance

becomes unacceptable.

C.1.5.2 Quality Assurance: Fort Gordon Forest Management personnel will monitor the Contractor's performance to ensure compliance with the performance work statement. The Government will monitor and evaluate Contractor's performance under this contract by 100% inspection of services pursuant to AR 420-76, Chapters 3-12.

C.1.6 Hours of Work: Work under this contract shall be performed during daylight hours only.

C.1.7 Work Period: All work required must be completed prior to 17 March 2004.

C.1.8 Damage Caused by Contractor: The Contractor shall be held accountable and liable for any damage to Government facilities, equipment or grounds, caused by the Contractor or his employees. The purpose for this contract is to reforest pine trees on non-stocked areas of the Fort Gordon, Military Installation.

C.1.9 Superintendence By The Contractor: The Contractor shall provide an on-site superintendent or a designated representative to be physically present during the normal hours of operation during the tree planting operation to act with full authority for the Contractor. This individual shall be responsible for the supervision, overall administration, and coordination of the required services. The superintendent shall be the point of contact with the Government and have the authority to act or make decisions for the Contractor. A pre-work conference between the Contractor or Contractor's superintendent, Corps of Engineer's POC and Fort Gordon Forest Management personnel is required on-site prior to commencement of work.

C.1.10 Alternate: An alternate shall be designated to act for the superintendent during absences such as illness.

C.2 GOVERNMENT FURNISHED PROPERTY AND SERVICES:

C.2.1 Fort Gordon Forest Management will provide a map indicating the tree planting areas.

C.2.2 All pine seedlings to be planted as described in this contract will be provided by the Government. Seedlings to be provided will be 1-year old container grown longleaf pine with a 6-inch soil plug. Seedlings provided will be extracted from containers and be packed in boxes of 100-500 seedlings per box. Seedlings will be stored in a cold storage facility on Fort Gordon and will be provided at the cold storage facility to the contractor on a daily basis.

C.3 CONTRACTOR FURNISHED SUPPLIES AND SERVICES:

C.3.1 Contractor shall supply all materials, labor, and equipment necessary to perform the services described herein.

C.4 SPECIFIC TASKS TO BE PERFORMED:

C.4.1 Tree Planting: Tree planting shall be conducted by hand using a 6-inch plug type-planting bar.

C.4.2 Seedlings shall be planted at a spacing of 6' x 12' (605 seedlings per acre). Only one seedling shall be planted in each debris free planting hole. Seedlings shall be planted straight in the hole at a depth that leaves terminal bud at or slightly below (0.3 inch) the soil surface. Soil shall be packed firmly around seedling roots.

C.4.3 Seedlings will be kept in closed shipping containers until immediately prior to planting. Seedling root plugs will not be exposed to the atmosphere for an extended period prior to planting. Containers will not be stored in direct sunlight at anytime. Seedlings will not be allowed to freeze.
