APPLICATION OF HERBICIDES
FT. GILLEM AND DOBBINS ARB, GEORGIA
SCOPE OF WORK

1. Scope of Work: The contractor shall furnish personnel, transportation, chemical, equipment, and supplies necessary to apply herbicides for:
 - a. KUDZU CONTROL on approximately 157.5 acres, plus 35 kudzu spots at Ft. Gillem, Georgia
 - b. KUDZU CONTROL on approximately 24.7 acres, plus 3 spots at Dobbins ARB, Georgia.
 - c. PINE RELEASE on approximately 28.8 acres at Ft. Gillem, Georgia.
 - d. VEGETATIVE CONTROL for Hiking Trail on approximately 0.96 acres at Dobbins ARB, Georgia
2. Care must be taken when operating equipment through these areas not to damage seedlings or mature trees. Herbicide treatments must be accomplished in such a manner as to limit the spray to the target plants and minimize drift onto pine seedlings or other non-target vegetation on the site. The contractor shall take all these variations into account when submitting a quote for each item.
3. Work Schedule: The treatment for all vegetative control work shall be conducted during the current growing season and completed not later than 15 September 2004 and follow-up treatments of any areas missed in the initial application as indicated by failure to "brown-up" must be completed by 15 October 2004. A pre-work conference is required on-site with the Contractor prior to commencement of work. Actual application work shall commence no later than 20 August 2004. Contractor shall submit to the Contracting Officer's Representative (COR) or his designee a work schedule indicating the locations, date, and time work shall be accomplished and be approved by the COR. The Contractor shall arrange his work so as not to cause interference with normal conduct of Government business.

Project Manager, Mr. Hank Cochran, shall be contacted within 7 days of planned commencement of operations to make necessary on site coordination. He may be contacted at the Fort Stewart Forest Resources Office, phone number. (912) 767-7522/7521.
4. Hours of Work: The Contractor will have access to the areas where the work is to be performed from 7:00 a.m. to 5:00 p.m. Monday-Friday, excluding federal holidays. Any change to this schedule requires the approval of the COR.
5. Contract Work Period: Work shall commence on or before 20 August 2004 and end not later than 15 September 2004. Reapplication treatments shall be completed by 15 October 2004.
6. Inspections: During the Request for Quote (RFQ) solicitation process, the Contracting Officer's Representative (COR), Mr. Hank Cochran (912-767-7522) will be available to show the areas to be treated to prospective quoters. Visitor badges will be necessary for all personnel entering the installations. The COR must accompany prospective bidders while they are on post to inspect treatment areas. Mr. Cochran will be available to show the areas to be treated on Fort Gillem on Thursday, 12 August 2004 10:00 A.M. and on Dobbins ARB at 1:00 P.M. Any contractor who wishes to attend these site visits should contact Mr. Cochran no later than 12 p.m. on the day prior to the scheduled showing.
7. Security Provisions: Ft. Gillem and Dobbins ARB are secure installations. The Contractor and Contractor personnel will be required to obtain a daily or weekly Access Pass from the installations Security Office

during the performance period. No weapons are allowed on the installation. Vehicles are subject to inspection. To gain access onto post the Contractor and his/her representative may be required to provide the following documents: drivers license and/or another form of picture I.D., vehicle registration and proof of insurance, and social security card.

8. Applicable Drawings: The attached aerial maps are applicable to the work area required herein and made part of these specifications. Application sites are outlined with the approximate number of acres in the treatment area.
9. Work Area: Herbicides shall be applied within areas bounded by roads, fencing, ditches, ponds and streams, openings, improvements, and orange flagging tape.
10. Contractor Qualifications: The Contractor shall provide a sufficient number of certified, trained and competent personnel to accomplish the work of this contract. The Contractor shall possess a valid State of Georgia Pesticide Contractor's License and a State of Georgia Commercial Applicator License in the appropriate category. Each individual directly involved with the application and/or supervision of the application of specified chemicals shall possess in the appropriate category a valid State of Georgia Commercial Applicator License and shall be certified in accordance with DOD Directive 4150.7.
11. Superintendence by the Contractor: The Contractor shall give his personal superintendence to the work or provide a competent Superintendent on the work site at all times during progress, with the authority to act on his or her behalf. The superintendent shall coordinate daily with the COR to advise of contract progress and to request access to upcoming work sites. A pre-work conference between the COR and the Contractor of the Contractor's representative is required on-site prior to commencement of work.
12. Materials, Labor and Equipment: Contractor shall supply herbicides, mixing water, mixing/storage tanks, vehicles, and materials, parts, labor and equipment necessary to perform the work. A water source may be provided for tank mixing on the military installation as designated by the COR. Tank mixing is subject to be spot-checked by Environmental and the COR or his representative. All herbicides must be secured within vehicles at all times while on the installation. Vehicles shall not be left unattended unless properly locked and secured. All vehicles shall be maintained with a clean and orderly appearance, free from observable herbicide spills, residues, or build-up. Equipment, tanks, and transport vehicles shall have observable signage stating "Pesticide Storage". Overnight parking of equipment and vehicles shall be in a place designated by the COR. The contractor will be required to provide the categories of equipment and materials listed below. Minimum equipment requirements are stated in paragraphs below:
 - a. Treatments for Kudzu Control and Vegetative Control for Hiking Trail shall be applied by means of spot-gun spraying or use of small all terrain vehicles for spraying the individual springs of green kudzu foliage occurring throughout the specified treatment areas. Low-volume application methods and application rates must be the proper equivalent to the high-volume rates specified. All kudzu and vegetative control applications shall be made from ground level while walking through the site or from an equivalent eye level ATV to reduce the potential for missing sprigs and minimize the amount of spray needed to properly cover each site. Draping kudzu vines shall be severed and the "root vine" chemically treated.
 - b. Treatment for Pine Release shall be applied by means of a tractor or skidder mounted chemical spraying equipment consisting of high pressure hose with hand-gun nozzle, directional jets, or equivalent as appropriate for the required chemical treatments in accordance with product labels and to adequately cover the entire treatment areas. Contractor must have method of assuring even coverage over treatment area.

Note: Truck or trailer mounted equipment shall not be substituted for the above specified equipment. The terrain is quite rough in areas and requires all terrain type vehicles to access the areas and provide proper coverage. Hose line may be pulled from application vehicle only to

reach those few areas which are not considered accessible by above specified equipment. Contractor may only use equipment specifically designed for use in herbicide application.

- b. All necessary equipment, including personal protective equipment (PPE), for completing specified work and in accordance with product label. Two (2) copies of the label and MSDS shall be furnished to the COR prior to work performance. The Contractor shall have a label and MSDS on site at all times and readily available for inspection at any time during application.
13. Herbicides Treatment Rate: Herbicide to be applied for:
- a. Kudzu Control are: Escort – 4 ounces plus 1 quart of 90/10 non-ionic surfactant per acre of kudzu foliage, tank mixed in the equivalent to 100 gallons of water, and applied with low pressure spray from spot-gun until kudzu foliage is saturated.
 - b. Pine Release: Arsenal-16 ounces plus 1 quart non-ionic surfactant per 30 gallons of water acre, and applied using a broadcast method.
 - c. Nature Trail-1 ½ quart of Round-Up plus 1 quart of non-ionic surfactant per 35 gallons of water applied with low pressure spray from spot-gun until the vegetation is saturated.
 - d. Contractor may propose to use herbicides other than the herbicides listed above. If a Contractor proposes to use herbicides other than those listed above he shall list the herbicides and the treatment rate in the quote. The Government will make a determination as to whether or not any proposed herbicides other than those listed above and the treatment rate are acceptable or unacceptable.
14. Check-In Locator: The Contractor shall check in each workday at a site designated by the COR. At the time of check-in the Contractor shall indicate the work and the sites of work for that date if different from previously scheduled activities.
15. Quality Control: The Contractor shall maintain a self-inspection system where the Superintendent identifies and promptly corrects contract performance deficiencies.
16. Quality Assurance: The government will provide quality assurance by monitoring the quality control system, inspecting contract performance and reporting deficiencies to the Superintendent for correction.
17. Container Disposal: Contractor shall reseal and dispose of empty pesticide containers off the installation at an authorized disposal site. The work area shall be cleared daily of cans, container, or lunch articles deposited by the contractor.
18. Herbicide Effectiveness: Contractor is required to obtain a 95% minimum kill within 2 weeks of application of each treatment area. The Contractor will be solely responsible for herbicide effectiveness. The COR will evaluate chemical effectiveness within 2 weeks following treatment to assess results. If vegetative kill is inadequate, the Contractor must re-apply chemical until a 95% kill is attained.
19. Care shall be taken to prevent chemical from entering streams or open water and all herbicide is to be applied in accordance with chemical labels. The herbicides shall be applied in such a manner as to prevent toxic exposure to personnel, pets, wildlife, ornamental plants, and any other non-target components of the environment. Applications shall not be made during or prior to imminent rainfall, immediately after heavy rains, rainfall of more than 1 inch in 24 hours, or while runoff is occurring, or following frost.
20. Care shall be taken to prevent chemical drift. The Contractor shall perform in strict accordance with the provisions of the Clean Air Act as applicable to this contract, including, but not limited to, no open burning or fugitive emissions. Extra care shall be taken to prevent drift off installation property to include, but not limited to, proper consideration of wind direction and variability at time of application.

21. If any hazardous waste (gasoline, used motor oil, etc.) is released into the environment during contract operations, it must be accumulated, managed and manifested off the installation in accordance with the regulations of the Resource Conservation and Recovery Act (430 CFR 260-280). The COR shall be notified immediately of the occurrence of any such event. Contractor shall be responsible for reporting, cleanup, and proper disposal of any hazardous waste generated. No petroleum products, oils, or lubricants (POL) may be willfully discharged into the environment, including spills due to negligence. Care must be taken when maintaining equipment not to release POL's onto the ground and the contractor is responsible for immediate cleanup and reporting of any such accidental release as discussed in the pre-work conference.
22. Reports: Accurate records of the amounts of herbicide used shall be maintained and presented to the COR and application quantities must be closely tracked and presented to the COR to insure proper reporting of quantity of active ingredients applied. The Contractor shall provide a daily report of active ingredient applied on DD Form 1532-1 which will be furnished by the COR. Report of pounds of active ingredient of specified herbicide applied per site or group of sites must be provided to the COR immediately following application. Herbicide usage records shall be completed daily (within 24 hours of application) and made immediately available on-site for inspection upon request of the COR. These daily usage reports shall be provided to the project office by mail at a minimum of once per workweek. Both postal and e-mail addresses shall be provided to the Contractor by the COR at the pre-work conference.
23. Payments: For any contract resulting from this solicitation payment shall be made as follows: Upon the successful completion of the work outlined in the specification for:
 - a. CLIN 0001 (Kudzu Control, Ft. Gillem, GA)
 - b. CLIN 0002 (Kudzu Control & Vegetative Control, Dobbins ARB, GA)
 - c. CLIN 0003 (Pine Release, Ft. Gillem, GA)

The contractor shall submit an invoice and subsequently receive payment in accordance with the payment terms of the contract.

CLAUSES INCORPORATED BY FULL TEXT

52.212-1 INSTRUCTIONS TO OFFERORS--COMMERCIAL ITEMS (JAN 2004)

(a) North American Industry Classification System (NAICS) code and small business size standard. The NAICS code and small business size standard for this acquisition appear in Block 10 of the solicitation cover sheet (SF 1449). However, the small business size standard for a concern which submits an offer in its own name, but which proposes to furnish an item which it did not itself manufacture, is 500 employees.

(b) Submission of offers. Submit signed and dated offers to the office specified in this solicitation at or before the exact time specified in this solicitation. Offers may be submitted on the SF 1449, letterhead stationery, or as otherwise specified in the solicitation. As a minimum, offers must show--

- (1) The solicitation number;
- (2) The time specified in the solicitation for receipt of offers;
- (3) The name, address, and telephone number of the offeror;
- (4) A technical description of the items being offered in sufficient detail to evaluate compliance with the requirements in the solicitation. This may include product literature, or other documents, if necessary;
- (5) Terms of any express warranty;
- (6) Price and any discount terms;
- (7) "Remit to" address, if different than mailing address;
- (8) A completed copy of the representations and certifications at FAR 52.212-3;
- (9) Acknowledgment of Solicitation Amendments;
- (10) Past performance information, when included as an evaluation factor, to include recent and relevant contracts for the same or similar items and other references (including contract numbers, points of contact with telephone numbers and other relevant information); and

(11) If the offer is not submitted on the SF 1449, include a statement specifying the extent of agreement with all terms, conditions, and provisions included in the solicitation. Offers that fail to furnish required representations or information, or reject the terms and conditions of the solicitation may be excluded from consideration.

(c) Period for acceptance of offers. The offeror agrees to hold the prices in its offer firm for 30 calendar days from the date specified for receipt of offers, unless another time period is specified in an addendum to the solicitation.

(d) Product samples. When required by the solicitation, product samples shall be submitted at or prior to the time specified for receipt of offers. Unless otherwise specified in this solicitation, these samples shall be submitted at no expense to the Government, and returned at the sender's request and expense, unless they are destroyed during preaward testing.

(e) Multiple offers. Offerors are encouraged to submit multiple offers presenting alternative terms and conditions or commercial items for satisfying the requirements of this solicitation. Each offer submitted will be evaluated separately.

(f) Late submissions, modifications, revisions, and withdrawals of offers:

(1) Offerors are responsible for submitting offers, and any modifications, revisions, or withdrawals, so as to reach the Government office designated in the solicitation by the time specified in the solicitation. If no time is specified in the solicitation, the time for receipt is 4:30 p.m., local time, for the designated Government office on the date that offers or revisions are due.

(2)(i) Any offer, modification, revision, or withdrawal of an offer received at the Government office designated in the solicitation after the exact time specified for receipt of offers is "late" and will not be considered unless it is received before award is made, the Contracting Officer determines that accepting the late offer would not unduly delay the acquisition; and--

(A) If it was transmitted through an electronic commerce method authorized by the solicitation, it was received at the initial point of entry to the Government infrastructure not later than 5:00 p.m. one working day prior to the date specified for receipt of offers; or

(B) There is acceptable evidence to establish that it was received at the Government installation designated for receipt of offers and was under the Government's control prior to the time set for receipt of offers; or

(C) If this solicitation is a request for proposals, it was the only proposal received.

(ii) However, a late modification of an otherwise successful offer, that makes its terms more favorable to the Government, will be considered at any time it is received and may be accepted.

(3) Acceptable evidence to establish the time of receipt at the Government installation includes the time/date stamp of that installation on the offer wrapper, other documentary evidence of receipt maintained by the installation, or oral testimony or statements of Government personnel.

(4) If an emergency or unanticipated event interrupts normal Government processes so that offers cannot be received at the Government office designated for receipt of offers by the exact time specified in the solicitation, and urgent Government requirements preclude amendment of the solicitation or other notice of an extension of the closing date, the time specified for receipt of offers will be deemed to be extended to the same time of day specified in the solicitation on the first work day on which normal Government processes resume.

(5) Offers may be withdrawn by written notice received at any time before the exact time set for receipt of offers. Oral offers in response to oral solicitations may be withdrawn orally. If the solicitation authorizes facsimile offers, offers may be withdrawn via facsimile received at any time before the exact time set for receipt of offers, subject to

the conditions specified in the solicitation concerning facsimile offers. An offer may be withdrawn in person by an offeror or its authorized representative if, before the exact time set for receipt of offers, the identity of the person requesting withdrawal is established and the person signs a receipt for the offer.

(g) Contract award (not applicable to Invitation for Bids). The Government intends to evaluate offers and award a contract without discussions with offerors. Therefore, the offeror's initial offer should contain the offeror's best terms from a price and technical standpoint. However, the Government reserves the right to conduct discussions if later determined by the Contracting Officer to be necessary. The Government may reject any or all offers if such action is in the public interest; accept other than the lowest offer; and waive informalities and minor irregularities in offers received.

(h) Multiple awards. The Government may accept any item or group of items of an offer, unless the offeror qualifies the offer by specific limitations. (d) Comptroller General Examination of Record. The Contractor shall comply with the provisions of this paragraph (d) if this contract was awarded using other than sealed bid, is in excess of the simplified acquisition threshold, and does not contain the clause at 52.215-2, Audit and Records--Negotiation.

(1) The Comptroller General of the United States, or an authorized representative of the Comptroller General, shall have access to and right to examine any of the Contractor's directly pertinent records involving transactions related to this contract.

(2) The Contractor shall make available at its offices at all reasonable times the records, materials, and other evidence for examination, audit, or reproduction, until 3 years after final payment under this contract or for any shorter period specified in FAR Subpart 4.7, Contractor Records Retention, of the other clauses of this contract. If this contract is completely or partially terminated, the records relating to the work terminated shall be made available for 3 years after any resulting final termination settlement. Records relating to appeals under the disputes clause or to litigation or the settlement of claims arising under or relating to this contract shall be made available until such appeals, litigation, or claims are finally resolved.

(3) As used in this clause, records include books, documents, accounting procedures and practices, and other data, regardless of type and regardless of form. This does not require the Contractor to create or maintain any record that the Contractor does not maintain in the ordinary course of business or pursuant to a provision of law.

(e) (1) Notwithstanding the requirements of the clauses in paragraphs (a), (b), (c), and (d) of this clause, the Contractor is not required to flow down any FAR clause, other than those in paragraphs (i) through (vi) of this paragraph in a subcontract for commercial items. Unless otherwise indicated below, the extent of the flow down shall be as required by the clause--

(i) 52.219-8, Utilization of Small Business Concerns (May 2004) (15 U.S.C. 637(d)(2) and (3)), in all subcontracts that offer further subcontracting opportunities. If the subcontract (except subcontracts to small business concerns) exceeds \$500,000 (\$1,000,000 for construction of any public facility), the subcontractor must include 52.219-8 in lower tier subcontracts that offer subcontracting opportunities.

52.222-41 SERVICE CONTRACT ACT OF 1965, AS AMENDED (MAY 1989)

(a) Definitions. "Act," as used in this clause, means the Service Contract Act of 1965, as amended (41 U.S.C. 351, et seq.).

"Contractor," as used in this clause or in any subcontract, shall be deemed to refer to the subcontractor, except in the term "Government Prime Contractor."

"Service employee," as used in this clause, means any person engaged in the performance of this contract other than any person employed in a bona fide executive, administrative, or professional capacity, as these terms are defined in Part 541 of Title 29, Code of Federal Regulations, as revised. It includes all such persons regardless of any contractual relationship that may be alleged to exist between a Contractor or subcontractor and such persons.

(b) Applicability. This contract is subject to the following provisions and to all other applicable provisions of the Act and regulations of the Secretary of Labor (29 CFR Part 4). This clause does not apply to contracts or subcontracts administratively exempted by the Secretary of Labor or exempted by 41 U.S.C. 356, as interpreted in Subpart C of 29 CFR Part 4.

(c) Compensation. (1) Each service employee employed in the performance of this contract by the Contractor or any subcontractor shall be paid not less than the minimum monetary wages and shall be furnished fringe benefits in accordance with the wages and fringe benefits determined by the Secretary of Labor, or authorized representative, as specified in any wage determination attached to this contract.

(2)(i) If a wage determination is attached to this contract, the Contractor shall classify any class of service employee which is not listed therein and which is to be employed under the contract (i.e., the work to be performed is not performed by any classification listed in the wage determination) so as to provide a reasonable relationship (i.e., appropriate level of skill comparison) between such unlisted classifications and the classifications listed in the wage determination. Such conformed class of employees shall be paid the monetary wages and furnished the fringe benefits as are determined pursuant to the procedures in this paragraph (c).

(ii) This conforming procedure shall be initiated by the Contractor prior to the performance of contract work by the unlisted class of employee. The Contractor shall submit Standard Form (SF) 1444, Request For Authorization of Additional Classification and Rate, to the Contracting Officer no later than 30 days after the unlisted class of

employee performs any contract work. The Contracting Officer shall review the proposed classification and rate and promptly submit the completed SF 1444 (which must include information regarding the agreement or disagreement of the employees' authorized representatives or the employees themselves together with the agency recommendation), and all pertinent information to the Wage and Hour Division, Employment Standards Administration, U.S. Department of Labor. The Wage and Hour Division will approve, modify, or disapprove the action or render a final determination in the event of disagreement within 30 days of receipt or will notify the Contracting Officer within 30 days of receipt that additional time is necessary.

(iii) The final determination of the conformance action by the Wage and Hour Division shall be transmitted to the Contracting Officer who shall promptly notify the Contractor of the action taken. Each affected employee shall be furnished by the Contractor with a written copy of such determination or it shall be posted as a part of the wage determination.

(iv)(A) The process of establishing wage and fringe benefit rates that bear a reasonable relationship to those listed in a wage determination cannot be reduced to any single formula. The approach used may vary from wage determination to wage determination depending on the circumstances. Standard wage and salary administration practices which rank various job classifications by pay grade pursuant to point schemes or other job factors may, for example, be relied upon. Guidance may also be obtained from the way different jobs are rated under Federal pay systems (Federal Wage Board Pay System and the General Schedule) or from other wage determinations issued in the same locality. Basic to the establishment of any conformable wage rate(s) is the concept that a pay relationship should be maintained between job classifications based on the skill required and the duties performed.

(B) In the case of a contract modification, an exercise of an option, or extension of an existing contract, or in any other case where a Contractor succeeds a contract under which the classification in question was previously conformed pursuant to paragraph (c) of this clause, a new conformed wage rate and fringe benefits may be assigned to the conformed classification by indexing (i.e., adjusting) the previous conformed rate and fringe benefits by an amount equal to the average (mean) percentage increase (or decrease, where appropriate) between the wages and fringe benefits specified for all classifications to be used on the contract which are listed in the current wage determination, and those specified for the corresponding classifications in the previously applicable wage determination. Where conforming actions are accomplished in accordance with this paragraph prior to the performance of contract work by the unlisted class of employees, the Contractor shall advise the Contracting Officer of the action taken but the other procedures in subdivision (c)(2)(ii) of this clause need not be followed.

(C) No employee engaged in performing work on this contract shall in any event be paid less than the currently applicable minimum wage specified under section 6(a)(1) of the Fair Labor Standards Act of 1938, as amended.

(v) The wage rate and fringe benefits finally determined under this subparagraph (c)(2) of this clause shall be paid to all employees performing in the classification from the first day on which contract work is performed by them in the classification. Failure to pay the unlisted employees the compensation agreed upon by the interested parties and/or finally determined by the Wage and Hour Division retroactive to the date such class of employees commenced contract work shall be a violation of the Act and this contract.

(vi) Upon discovery of failure to comply with subparagraph (c)(2) of this clause, the Wage and Hour Division shall make a final determination of conformed classification, wage rate, and/or fringe benefits which shall be retroactive to the date such class or classes of employees commenced contract work.

(3) Adjustment of Compensation. If the term of this contract is more than 1 year, the minimum monetary wages and fringe benefits required to be paid or furnished thereunder to service employees under this contract shall be subject to adjustment after 1 year and not less often than once every 2 years, under wage determinations issued by the Wage and Hour Division.

(d) Obligation to Furnish Fringe Benefits. The Contractor or subcontractor may discharge the obligation to furnish fringe benefits specified in the attachment or determined under subparagraph (c)(2) of this clause by furnishing equivalent combinations of bona fide fringe benefits, or by making equivalent or differential cash payments, only in

accordance with Subpart D of 29 CFR Part 4.

(e) Minimum Wage. In the absence of a minimum wage attachment for this contract, neither the Contractor nor any subcontractor under this contract shall pay any person performing work under this contract (regardless of whether the person is a service employee) less than the minimum wage specified by section 6(a)(1) of the Fair Labor Standards Act of 1938. Nothing in this clause shall relieve the Contractor or any subcontractor of any other obligation under law or contract for payment of a higher wage to any employee.

(f) Successor Contracts. If this contract succeeds a contract subject to the Act under which substantially the same services were furnished in the same locality and service employees were paid wages and fringe benefits provided for in a collective bargaining agreement, in the absence of the minimum wage attachment for this contract setting forth such collectively bargained wage rates and fringe benefits, neither the Contractor nor any subcontractor under this contract shall pay any service employee performing any of the contract work (regardless of whether or not such employee was employed under the predecessor contract), less than the wages and fringe benefits provided for in such collective bargaining agreement, to which such employee would have been entitled if employed under the predecessor contract, including accrued wages and fringe benefits and any prospective increases in wages and fringe benefits provided for under such agreement. No Contractor or subcontractor under this contract may be relieved of the foregoing obligation unless the limitations of 29 CFR 4.1b(b) apply or unless the Secretary of Labor or the Secretary's authorized representative finds, after a hearing as provided in 29 CFR 4.10 that the wages and/or fringe benefits provided for in such agreement are substantially at variance with those which prevail for services of a character similar in the locality, or determines, as provided in 29 CFR 4.11, that the collective bargaining agreement applicable to service employees employed under the predecessor contract was not entered into as a result of arm's length negotiations. Where it is found in accordance with the review procedures provided in 29 CFR 4.10 and/or 4.11 and Parts 6 and 8 that some or all of the wages and/or fringe benefits contained in a predecessor Contractor's collective bargaining agreement are substantially at variance with those which prevail for services of a character similar in the locality, and/or that the collective bargaining agreement applicable to service employees employed under the predecessor contract was not entered into as a result of arm's length negotiations, the Department will issue a new or revised wage determination setting forth the applicable wage rates and fringe benefits. Such determination shall be made part of the contract or subcontract, in accordance with the decision of the Administrator, the Administrative Law Judge, or the Board of Service Contract Appeals, as the case may be, irrespective of whether such issuance occurs prior to or after the award of a contract or subcontract (53 Comp. Gen. 401 (1973)). In the case of a wage determination issued solely as a result of a finding of substantial variance, such determination shall be effective as of the date of the final administrative decision.

(g) Notification to Employees. The Contractor and any subcontractor under this contract shall notify each service employee commencing work on this contract of the minimum monetary wage and any fringe benefits required to be paid pursuant to this contract, or shall post the wage determination attached to this contract. The poster provided by the Department of Labor (Publication WH 1313) shall be posted in a prominent and accessible place at the worksite. Failure to comply with this requirement is a violation of section 2(a)(4) of the Act and of this contract.

(h) Safe and Sanitary Working Conditions. The Contractor or subcontractor shall not permit any part of the services called for by this contract to be performed in buildings or surroundings or under working conditions provided by or under the control or supervision of the Contractor or subcontractor which are unsanitary, hazardous, or dangerous to the health or safety of the service employees. The Contractor or subcontractor shall comply with the safety and health standards applied under 29 CFR Part 1925.

(i) Records. (1) The Contractor and each subcontractor performing work subject to the Act shall make and maintain for 3 years from the completion of the work, and make them available for inspection and transcription by authorized representatives of the Wage and Hour Division, Employment Standards Administration, a record of the following:

(i) For each employee subject to the Act--

(A) Name and address and social security number;

- (B) Correct work classification or classifications, rate or rates of monetary wages paid and fringe benefits provided, rate or rates of payments in lieu of fringe benefits, and total daily and weekly compensation;
- (C) Daily and weekly hours worked by each employee; and
- (D) Any deductions, rebates, or refunds from the total daily or weekly compensation of each employee.
- (ii) For those classes of service employees not included in any wage determination attached to this contract, wage rates or fringe benefits determined by the interested parties or by the Administrator or authorized representative under the terms of paragraph (c) of this clause. A copy of the report required by subdivision (c)(2)(ii) of this clause will fulfill this requirement.
- (iii) Any list of the predecessor Contractor's employees which had been furnished to the Contractor as prescribed by paragraph (n) of this clause.
- (2) The Contractor shall also make available a copy of this contract for inspection or transcription by authorized representatives of the Wage and Hour Division.
- (3) Failure to make and maintain or to make available these records for inspection and transcription shall be a violation of the regulations and this contract, and in the case of failure to produce these records, the Contracting Officer, upon direction of the Department of Labor and notification to the Contractor, shall take action to cause suspension of any further payment or advance of funds until the violation ceases.
- (4) The Contractor shall permit authorized representatives of the Wage and Hour Division to conduct interviews with employees at the worksite during normal working hours.
- (j) Pay Periods. The Contractor shall unconditionally pay to each employee subject to the Act all wages due free and clear and without subsequent deduction (except as otherwise provided by law or regulations, 29 CFR Part 4), rebate, or kickback on any account. These payments shall be made no later than one pay period following the end of the regular pay period in which the wages were earned or accrued. A pay period under this Act may not be of any duration longer than semi-monthly.
- (k) Withholding of Payments and Termination of Contract. The Contracting Officer shall withhold or cause to be withheld from the Government Prime Contractor under this or any other Government contract with the Prime Contractor such sums as an appropriate official of the Department of Labor requests or such sums as the Contracting Officer decides may be necessary to pay underpaid employees employed by the Contractor or subcontractor. In the event of failure to pay any employees subject to the Act all or part of the wages or fringe benefits due under the Act, the Contracting Officer may, after authorization or by direction of the Department of Labor and written notification to the Contractor, take action to cause suspension of any further payment or advance of funds until such violations have ceased. Additionally, any failure to comply with the requirements of this clause may be grounds for termination of the right to proceed with the contract work. In such event, the Government may enter into other contracts or arrangements for completion of the work, charging the Contractor in default with any additional cost.
- (l) Subcontracts. The Contractor agrees to insert this clause in all subcontracts subject to the Act.
- (m) Collective Bargaining Agreements Applicable to Service Employees. If wages to be paid or fringe benefits to be furnished any service employees employed by the Government Prime Contractor or any subcontractor under the contract are provided for in a collective bargaining agreement which is or will be effective during any period in which the contract is being performed, the Government Prime Contractor shall report such fact to the Contracting Officer, together with full information as to the application and accrual of such wages and fringe benefits, including any prospective increases, to service employees engaged in work on the contract, and a copy of the collective bargaining agreement. Such report shall be made upon commencing performance of the contract, in the case of collective bargaining agreements effective at such time, and in the case of such agreements or provisions or

amendments thereof effective at a later time during the period of contract performance such agreements shall be reported promptly after negotiation thereof.

(n) Seniority List. Not less than 10 days prior to completion of any contract being performed at a Federal facility where service employees may be retained in the performance of the succeeding contract and subject to a wage determination which contains vacation or other benefit provisions based upon length of service with a Contractor (predecessor) or successor (29 CFR 4.173), the incumbent Prime Contractor shall furnish the Contracting Officer a certified list of the names of all service employees on the Contractor's or subcontractor's payroll during the last month of contract performance. Such list shall also contain anniversary dates of employment on the contract either with the current or predecessor Contractors of each such service employee. The Contracting Officer shall turn over such list to the successor Contractor at the commencement of the succeeding contract.

(o) Rulings and Interpretations. Rulings and interpretations of the Act are contained in Regulations, 29 CFR Part 4.

(p) Contractor's Certification. (1) By entering into this contract, the Contractor (and officials thereof) certifies that neither it (nor he or she) nor any person or firm who has a substantial interest in the Contractor's firm is a person or firm ineligible to be awarded Government contracts by virtue of the sanctions imposed under section 5 of the Act.

(2) No part of this contract shall be subcontracted to any person or firm ineligible for award of a Government contract under section 5 of the Act.

(3) The penalty for making false statements is prescribed in the U.S. Criminal Code, 18 U.S.C. 1001.

(q) Variations, Tolerances, and Exemptions Involving Employment. Notwithstanding any of the provisions in paragraphs (b) through (o) of this clause, the following employees may be employed in accordance with the following variations, tolerances, and exemptions, which the Secretary of Labor, pursuant to section 4(b) of the Act prior to its amendment by Pub. L. 92-473, found to be necessary and proper in the public interest or to avoid serious impairment of the conduct of Government business:

(1) Apprentices, student-learners, and workers whose earning capacity is impaired by age, physical or mental deficiency, or injury may be employed at wages lower than the minimum wages otherwise required by section 2(a)(1) or 2(b)(1) of the Act without diminishing any fringe benefits or cash payments in lieu thereof required under section 2(a)(2) of the Act, in accordance with the conditions and procedures prescribed for the employment of apprentices, student-learners, handicapped persons, and handicapped clients of sheltered workshops under section 14 of the Fair Labor Standards Act of 1938, in the regulations issued by the Administrator (29 CFR Parts 520, 521, 524, and 525).

(2) The Administrator will issue certificates under the Act for the employment of apprentices, student-learners, handicapped persons, or handicapped clients of sheltered workshops not subject to the Fair Labor Standards Act of 1938, or subject to different minimum rates of pay under the two acts, authorizing appropriate rates of minimum wages (but without changing requirements concerning fringe benefits or supplementary cash payments in lieu thereof), applying procedures prescribed by the applicable regulations issued under the Fair Labor Standards Act of 1938 (29 CFR Parts 520, 521, 524, and 525).

(3) The Administrator will also withdraw, annul, or cancel such certificates in accordance with the regulations in 29 CFR Parts 525 and 528.

(r) Apprentices. Apprentices will be permitted to work at less than the predetermined rate for the work they perform when they are employed and individually registered in a bona fide apprenticeship program registered with a State Apprenticeship Agency which is recognized by the U.S. Department of Labor, or if no such recognized agency exists in a State, under a program registered with the Bureau of Apprenticeship and Training, Employment and Training Administration, U.S. Department of Labor. Any employee who is not registered as an apprentice in an approved program shall be paid the wage rate and fringe benefits contained in the applicable wage determination for the journeyman classification of work actually performed. The wage rates paid apprentices shall not be less than the

wage rate for their level of progress set forth in the registered program, expressed as the appropriate percentage of the journeyman's rate contained in the applicable wage determination. The allowable ratio of apprentices to journeymen employed on the contract work in any craft classification shall not be greater than the ratio permitted to the Contractor as to his entire work force under the registered program.

(s) Tips. An employee engaged in an occupation in which the employee customarily and regularly receives more than \$30 a month in tips may have the amount of these tips credited by the employer against the minimum wage required by section 2(a)(1) or section 2(b)(1) of the Act, in accordance with section 3(m) of the Fair Labor Standards Act and Regulations, 29 CFR Part 531. However, the amount of credit shall not exceed \$1.34 per hour beginning January 1, 1981. To use this provision--

- (1) The employer must inform tipped employees about this tip credit allowance before the credit is utilized;
- (2) The employees must be allowed to retain all tips (individually or through a pooling arrangement and regardless of whether the employer elects to take a credit for tips received);
- (3) The employer must be able to show by records that the employee receives at least the applicable Service Contract Act minimum wage through the combination of direct wages and tip credit; and
- (4) The use of such tip credit must have been permitted under any predecessor collective bargaining agreement applicable by virtue of section 4(c) of the Act.

Disputes Concerning Labor Standards. The U.S. Department of Labor has set forth in 29 CFR Parts 4, 6, and 8 procedures for resolving disputes concerning labor standards requirements. Such disputes shall be resolved in accordance with those procedures and not the Disputes clause of this contract. Disputes within the meaning of this clause include disputes between the Contractor (or any of its subcontractors) and the contracting agency, the U.S. Department of Labor, or the employees or their representatives.
