STATEMENT OF WORK

Cold War Survey
Fort Bragg, NC

1. INTRODUCTION:

The Department of Defense (DoD) is the steward of a vast number of historical properties located on millions of acres of public land. Federal regulations require that DoD installations accomplish their military missions in compliance with cultural resource laws, including the National Historic Preservation Act (NHPA) of 1966 (as amended). In accordance with Section 110 of the NHPA, Fort Bragg must identify and evaluate historic properties and determine eligibility for the National Register of Historic Places (NRHP). The work outlined herein represents an attempt to identify, document and evaluate historic properties associated with the Cold War that have achieved significance within the Period of Significance, 1945-1989.

Fort Bragg, North Carolina, is comprised of over 160,000 acres within five counties in eastern North Carolina. Within its bounds are over 300 historic buildings, 3 historic districts, 27 cemeteries, and at least 56 archaeological sites that have been identified, documented, and determined eligible for listing in the National Register of Historic Places. An intensive architectural survey was conducted at Fort Bragg in 1996 and updated in 2000 by M. Ruth Little. This survey evaluated the majority of buildings on Fort Bragg built between 1918 and 1950. Cold War resources were not identified or evaluated as a result of the 2000 survey.

Fort Bragg was very active during the Cold War era, 1946-1989. The most significant events at Fort Bragg during this era were that Fort Bragg became the "Home of the Airborne" and the creation of Special Operations and Special Forces. According to Department of Defense interim guidance, buildings, structures and objects associated with these events should be evaluated for National Register eligibility. In addition, major upgrades were made to Soldier's housing and barracks. Although unaccompanied personnel housing (UPH or barracks) are ineligible for listing under the interim guidance, for the purposes at Fort Bragg, documentation of at least one building per housing type within the Period of Significance is required as part of this project. The need to renew Army resources has resulted in the demolition and /or planned demolition of buildings, structures and objects that were built between 1945 and 1989. In accordance with Section 110 it is Fort Bragg's responsibility to identify any buildings constructed during this time and evaluate their significance and eligibility for listing in the National Register of Historic Places under the context of the Cold War.

Nearly 1000 buildings and structures were constructed on Fort Bragg between 1945 and 1989, exclusive of housing. It is estimated that approximately 40-50 buildings and structures will be included in the Cold War inventory. Of the 40-50 buildings and structures, it is estimated that less than 10 will meet the criteria for listing in the National Register under Criteria A or C.

2. Objectives

The following are objectives of this Scope of Work (SOW):

- a. Identify buildings and structures that are associated with significant Cold War themes;
- b. Record all Cold War buildings and structures;
- c. Prepare a Cold War historic context for Fort Bragg
- d. Evaluate Cold War buildings and structures for National Register listing;
- e. Present results in detailed report that includes historic context and NRHP recommendations.

3. Tasks

The following tasks will be completed to meet the objectives stated above:

- a. **Archival Research.** The contractor shall conduct archival research at state, local and federal repositories to construct a historic context for Fort Bragg during the Cold War era. This context shall be the framework for evaluating the buildings, structures and barracks styles.
- b. **Fieldwork/Survey.** The contractor shall conduct a survey and compile an inventory of all Cold War buildings, structures and objects on Fort Bragg. The contractor shall evaluate buildings and structures for NRHP listing using existing Cold War directives, eligibility reports and Department of Defense interim guidance. Guidance may be found in the report “Coming in from the Cold: Military Heritage in the Cold War,” Report on the Department of Defense Legacy Cold War Project. The contractor shall refer to the guidance listed in appendix IV, “Interim Guidance. Treatment of Cold War Historic Properties for the US Air Force Installations; Department of Navy Cultural Resources Program Note No. 7: Historic Cold War Properties. A copy of the report can be downloaded from the following site:

- c. **Large Format Photography.** The contractor shall document the Cold War era barracks using large format photography in accordance with the guidelines found in *Secretary of Interior’s Guidelines for Architectural and Engineering Documentation* [68 FR 43159] (<http://www.cr.nps.gov/habshaer/pubs/hhh%20guidelines%202003.pdf>). Photographs of representative barracks styles will be taken rather than photos of all barracks. There are 5 barracks styles. Photographs of each elevation, each barracks style in its environment and distinguishing features shall be taken.

- d. **Documentation of buildings.** The contractor shall complete a North Carolina State Survey form for each building, structure and barracks type that falls under the purview of a Cold War property. In addition to completing the form, 35mm black and white photos and slides shall be taken of each building, structure and barracks style. Inventory forms will be obtained from the North Carolina State Historic Preservation Office or Fort Bragg, CRP. It is estimated that between 25-50 forms will be completed.
- e. **Report preparation.** The contractor shall prepare draft, revised draft and final reports summarizing the project design, objectives, and findings of the survey. The report shall include a historic context, prepared by the contractor, that was used to determine NRHP eligibility of the buildings and structures. Photographs of each building, structure and object recorded will be included. Determine and justify the eligibility of buildings, structures, and objects for inclusion in the National Register of Historic Places under the context of the Cold War. The completed North Carolina State Survey forms shall be included as a separate appendix or volume, depending on the number of forms completed.
- f. **Curation.** The contractor shall prepare all project records, photographs, maps, and other materials for long-term curation by Fort Bragg. Preparation shall be accomplished in accordance with 36 CFR 79, Curation of Federally Owned and Administered Archeological Collections.

4. Deliverables/Submittals

The following is a list of required submittals or deliverables. Unless otherwise stated, all deliverables will be sent to Ms. Julie Morgan, Savannah District, at the address listed in Section 7.

a. *Monthly Progress Reports.* One (1) word-processed report describing progress on the project shall be submitted. Report shall contain a brief description of work performed during the previous month and any problems/concerns/scheduling changes that may affect the schedule of the final deliverable. Each monthly report shall show, in bold-faced type, the dates of the end of the period of services for this task order, as well as the dates when the draft and final reports are due to be submitted. This is intended to assist in timely completion of the project, and in avoiding a situation wherein the contract expires prior to submission of all deliverables. Progress reports may be submitted either electronically via email or through the US Postal Service or other mail carrier service. The first and last report may cover more than a month with prior concurrence of the government.

b. *Large Format photographs:* Per the *Guidelines* large format photographs are defined as: photographs taken of historic buildings, sites, structures, objects, or landscapes where the dimensions of the negative are either 4"x 5", 5"x 7", or 8"x 10" and where the photographs are taken with appropriate means to correct perspective distortion. Photographs shall include at least one photograph with a scale, usually of the principal façade. It is estimated that 20-30 photographs will be submitted. Photographs shall be submitted electronically to Jeff Irwin, Fort

Bragg, for selection of final photographs. A CD containing the photographs will be required also. All photographs and negatives shall be submitted in archival quality storage sleeves.

c. *Draft, revised draft, final reports:* Draft and final reports shall include a historic context that was used to evaluate the resources as well as the individual NRHP recommendations for each Cold War structure or building. In addition to the historic context, the report shall minimally include a field methods section that details how fieldwork was conducted, and photographs of all buildings recommended eligible for the NRHP. The contractor may be asked to submit a revised draft report if substantial comments result from review of the draft report. The revised draft report will address comments made by Fort Bragg, Savannah District, or other designated reviewers.

The final report shall be submitted after acceptance of the draft or revised draft report. It is estimated that this report will be submitted within 60 days after submittal of the draft report. The contractor shall prepare a final report that incorporates the comments provided by the Government and other reviewers that have been designated by the Government. Should the Contractor prefer not to include one or more of the substantive changes requested by the government, the Contractor shall explain his/her reasons for this preference in writing prior to printing of the final report. The bound reports shall contain laminated covers. One copy shall be unbound printed on acid-free paper.

All of the files used to produce the final report (including all text, tables, figures, plates, references, etc.), site forms, maps, and artifact lists shall be copied to a CD and submitted along with the final report. Each CD shall be accompanied by a written hard copy list explaining file names, file contents, etc. Each CD shall be neatly labeled with the Contractor's firm, project title, contract number, and date. Text files shall be readable by Microsoft Word 6.0 with no loss of formatting. The Contractor shall be responsible for correcting any loss of formatting that may occur if the electronic files are submitted in a format other than Microsoft Word 6.0.

d. *North Carolina State survey forms:* The contractor shall submit completed survey forms for the Cold War resources identified during the field survey. The contractor shall obtain the forms from either Fort Bragg or the North Carolina State Historic Preservation Office. It is assumed that group rather than individual forms will be completed. The forms entail a description of the resource as well as photographs. Paper copies of the forms shall be submitted to the North Carolina SHPO. In addition to the paper copies, a copy of all forms shall be submitted on a CD. Photos shall also be submitted on CD.

e. *Curated Materials:* All notes, photographs, negatives, maps, drawings, etc. shall be prepared for curation and submitted along with the final report. These materials shall be sent directly to the Fort Bragg CRP. Digital photographs shall be submitted on labeled CDs. Each CD of digital photographs shall also include a copy of the relevant photograph logs.

5. Contractor Responsibilities

To perform the required work, the Contractor shall provide all professional staff, support staff, and specialists necessary to plan, supervise, perform, and report the required work. The Contractor shall furnish all labor, facilities, transportation, fuel, equipment, and material necessary to perform the services required. The Contractor shall also provide adequate professional supervision to assure the accuracy, quality, and completeness of all work required under this contract.

The Contractor shall schedule survey visits with the Ft. Bragg Cultural Resource Program, Fort Bragg Range Control, and specific commands responsible for individual buildings or facilities currently in use. Because Fort Bragg is a secure installation it is essential that the Contractor coordinate all requests with the appropriate offices.

The Contractor shall participate in interaction concerning Fort Bragg with representatives of the North Carolina State Historic Preservation Office (SHPO) and the Advisory Council on Historic Preservation (ACHP) only upon specific, case-by-case direction from the Fort Bragg Cultural Resource Program.

The Contractor will at all times conduct operations in a safe manner and in accordance with the US Army Corps of Engineers Safety and Health Requirements Manual (EM 385-1-1, 3 November 2003, <http://www.usace.army.mil/publications/eng-manuals/em385-1-1/entire.pdf>).

11. General Provisions

Neither the Contractor nor their representative shall release or publish any sketch, photograph, report, or other material of any nature derived or prepared under this SOW without written permission of the Government except as is specifically provided for in this SOW. Copyright shall not be claimed by the Contractor for any materials produced under this SOW. The report shall not include copyrighted material unless the Contractor provides the Government with written permission to use such copyrighted material. All deliverables are to remain in the public domain. The Contractor and those in his/her employ may, during the term of this agreement, present reports of research from this project to various professional societies and publications. Abstracts and copies of these reports, presentations, or articles utilizing work sponsored by the Government shall be provided to Savannah District and Fort Bragg CRP for approval prior to publication or presentation.

In the event that the Contractor encounters problems in fulfilling performance requirements, or when difficulties are anticipated in complying with the stated schedule or dates, or whenever the Contractor has knowledge that any actual or potential situation is delaying or threatening to delay timely performance of tasks, the Contractor shall immediately notify Julie Morgan, Savannah District, by telephone communication and in writing all relevant details. However, this material shall be informational in character and this provision shall not be construed as a waiver by the U.S. Government of any delivery schedule or date, rights, or remedies provided by law or under this contract.

The Contractor shall provide Julie Morgan, Savannah District, with copies of field records, maps, or other works in progress prior to the submission of the draft report if such materials are needed for the preparation of Savannah District (Government) in-house work or reports, planning documents, or presentations.

13. Contractor Qualifications

To be eligible for the project described in this Statement of Work, the Contractor shall provide evidence that the person(s) who directs the fieldwork and serves as primary author of the report meet(s) the following qualifications:

- 1) a graduate degree (Masters or Ph.D.) or ABD status (i.e., doctoral candidate) in historic preservation, landscape architecture or related field.
- 2) previous experience conducting inventory and evaluation of historic buildings.
- 3) previous experience serving as the primary author of a professional quality technical report.
- 4) previous experience with large-format black and white photography and HABS/HAER photography.
- 5) familiarity with military and architectural history, as demonstrated by having authored or co-authored previous reports on those topics.

(b) Submission of offers. Submit signed and dated offers to the office specified in this solicitation at or before the exact time specified in this solicitation. Offers may be submitted on the SF 1449, letterhead stationery, or as otherwise specified in the solicitation. As a minimum, offers must show--

52.212-4 CONTRACT TERMS AND CONDITIONS-- COMMERCIAL ITEMS (OCT 2003)

(a) Inspection/Acceptance. The Contractor shall only tender for acceptance those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or

reperformance of nonconforming services at no increase in contract price. The Government must exercise its post-acceptance rights (1) within a reasonable time after the defect was discovered or should have been discovered; and (2) before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(b) Assignment. The Contractor or its assignee may assign its rights to receive payment due as a result of performance of this contract to a bank, trust company, or other financing institution, including any Federal lending agency in accordance with the Assignment of Claims Act (31 U.S.C. 3727). However, when a third party makes payment (e.g., use of the Governmentwide commercial purchase card), the Contractor may not assign its rights to receive payment under this contract.

(c) Changes. Changes in the terms and conditions of this contract may be made only by written agreement of the parties.

(d) Disputes. This contract is subject to the Contract Disputes Act of 1978, as amended (41 U.S.C. 601-613). Failure of the parties to this contract to reach agreement on any request for equitable adjustment, claim, appeal or action arising under or relating to this contract shall be a dispute to be resolved in accordance with the clause at FAR 52.233-1, Disputes, which is incorporated herein by reference. The Contractor shall proceed diligently with performance of this contract, pending final resolution of any dispute arising under the contract.

(e) Definitions. The clause at FAR 52.202-1, Definitions, is incorporated herein by reference.

(f) Excusable delays. The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence such as, acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. The Contractor shall notify the Contracting Officer in writing as soon as it is reasonably possible after the commencement or any excusable delay, setting for the full particulars in connection therewith, shall remedy such occurrence with all reasonable dispatch and shall promptly give written notice to the Contracting Officer of the cessation of such occurrence.

(g) Invoice. (1) The Contractor shall submit an original invoice and three copies (or electronic invoice, if authorized) to the address designated in the contract to receive invoices. An invoice must include--

(i) Name and address of the Contractor;

(ii) Invoice date and number;

(iii) Contract number, contract line item number and, if applicable, the order number;

(iv) Description, quantity, unit of measure, unit price and extended price of the items delivered;

(v) Shipping number and date of shipment, including the bill of lading number and weight of shipment if shipped on Government bill of lading;

(vi) Terms of any discount for prompt payment offered;

(vii) Name and address of official to whom payment is to be sent;

(viii) Name, title, and phone number of person to notify in event of defective invoice; and

(ix) Taxpayer Identification Number (TIN). The Contractor shall include its TIN on the invoice only if required elsewhere in this contract.

(x) Electronic funds transfer (EFT) banking information.

(A) The Contractor shall include EFT banking information on the invoice only if required elsewhere in this contract.

(B) If EFT banking information is not required to be on the invoice, in order for the invoice to be a proper invoice, the Contractor shall have submitted correct EFT banking information in accordance with the applicable solicitation provision, contract clause (e.g., 52.232-33, Payment by Electronic Funds Transfer--Central Contractor Registration, or 52.232-34, Payment by Electronic Funds Transfer--Other Than Central Contractor Registration), or applicable agency procedures.

(C) EFT banking information is not required if the Government waived the requirement to pay by EFT.

(2) Invoices will be handled in accordance with the Prompt Payment Act (31 U.S.C. 3903) and Office of Management and Budget (OMB) prompt payment regulations at 5 CFR part 1315.

(h) Patent indemnity. The Contractor shall indemnify the Government and its officers, employees and agents against liability, including costs, for actual or alleged direct or contributory infringement of, or inducement to infringe, any United States or foreign patent, trademark or copyright, arising out of the performance of this contract, provided the Contractor is reasonably notified of such claims and proceedings.

(i) Payment.--

(1) Items accepted. Payment shall be made for items accepted by the Government that have been delivered to the delivery destinations set forth in this contract.

(2) Prompt payment. The Government will make payment in accordance with the Prompt Payment Act (31 U.S.C. 3903) and prompt payment regulations at 5 CFR part 1315.

(3) Electronic Funds Transfer (EFT). If the Government makes payment by EFT, see 52.212-5(b) for the appropriate EFT clause.

(4) Discount. In connection with any discount offered for early payment, time shall be computed from the date of the invoice. For the purpose of computing the discount earned, payment shall be considered to have been made on the date which appears on the payment check or the specified payment date if an electronic funds transfer payment is made.

(5) Overpayments. If the Contractor becomes aware of a duplicate contract financing or invoice payment or that the Government has otherwise overpaid on a contract financing or invoice payment, the Contractor shall immediately notify the Contracting Officer and request instructions for disposition of the overpayment.

(j) Risk of loss. Unless the contract specifically provides otherwise, risk of loss or damage to the supplies provided under this contract shall remain with the Contractor until, and shall pass to the Government upon:

(1) Delivery of the supplies to a carrier, if transportation is f.o.b. origin; or

(2) Delivery of the supplies to the Government at the destination specified in the contract, if transportation is f.o.b. destination.

(k) Taxes. The contract price includes all applicable Federal, State, and local taxes and duties.

(l) Termination for the Government's convenience. The Government reserves the right to terminate this contract, or any part hereof, for its sole convenience. In the event of such termination, the Contractor shall immediately stop all work hereunder and shall immediately cause any and all of its suppliers and subcontractors to cease work. Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage

of the work performed prior to the notice of termination, plus reasonable charges the Contractor can demonstrate to the satisfaction of the Government using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred which reasonably could have been avoided.

(m) Termination for cause. The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(n) Title. Unless specified elsewhere in this contract, title to items furnished under this contract shall pass to the Government upon acceptance, regardless of when or where the Government takes physical possession.

(o) Warranty. The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.

(p) Limitation of liability. Except as otherwise provided by an express warranty, the Contractor will not be liable to the Government for consequential damages resulting from any defect or deficiencies in accepted items.

(q) Other compliances. The Contractor shall comply with all applicable Federal, State and local laws, executive orders, rules and regulations applicable to its performance under this contract.

(r) Compliance with laws unique to Government contracts. The Contractor agrees to comply with 31 U.S.C. 1352 relating to limitations on the use of appropriated funds to influence certain Federal contracts; 18 U.S.C. 431 relating to officials not to benefit; 40 U.S.C. 327, et seq., Contract Work Hours and Safety Standards Act; 41 U.S.C. 51-58, Anti-Kickback Act of 1986; 41 U.S.C. 265 and 10 U.S.C. 2409 relating to whistleblower protections; 49 U.S.C. 40118, Fly American; and 41 U.S.C. 423 relating to procurement integrity.

(s) Order of precedence. Any inconsistencies in this solicitation or contract shall be resolved by giving precedence in the following order: (1) the schedule of supplies/services; (2) the Assignments, Disputes, Payments, Invoice, Other Compliances, and Compliance with Laws Unique to Government Contracts paragraphs of this clause; (3) the clause at 52.212-5; (4) addenda to this solicitation or contract, including any license agreements for computer software; (5) solicitation provisions if this is a solicitation; (6) other paragraphs of this clause; (7) the Standard Form 1449; (8) other documents, exhibits, and attachments; and (9) the specification.

(t) Central Contractor Registration (CCR). (1) Unless exempted by an addendum to this contract, the Contractor is responsible during performance and through final payment of any contract for the accuracy and completeness of the data within the CCR database, and for any liability resulting from the Government's reliance on inaccurate or incomplete data. To remain registered in the CCR database after the initial registration, the Contractor is required to review and update on an annual basis from the date of initial registration or subsequent updates its information in the CCR database to ensure it is current, accurate and complete. Updating information in the CCR does not alter the terms and conditions of this contract and is not a substitute for a properly executed contractual document.
